State Sued Over Waiting List

The New Jersey Protection and Advocacy, Inc., ("NJP&A") today filed a lawsuit in the United States District Court for the District of New Jersey against the New Jersey Department of Human Services for failure to comply with federal laws requiring states to provide services to the developmentally disabled in the most integrated setting. Lowenstein Sandler PC is representing NJP&A on a pro bono basis.

In the suit, NJP&A alleges that the State has systematically failed and refused to provide required services to thousands of developmentally disabled citizens who have sought community-based services--rather than services provided in an institutional setting --over the last decade. NJP&A's suit specifically challenges the State's practice of "waitlisting" individuals who seek community services and placements. NJP&A alleges that the waitlist for community services is illusory, as most of those waitlisted are never provided with community services and never come off the waitlist. Despite clear and ambiguous directions under the Americans with Disabilities Act that "states providing services to the developmentally disabled using Medicaid funding must do so with 'reasonable promptness' " many of the more than 8,000 qualified NJ citizens on the waitlist have been waiting for services for many years.

The complaint alleges that wait-listing eligible citizens is not a substitute for providing home and community-based services required by the state and in compliance with federal law. According to the complaint, most of the people on the waitlist live at home or with relatives, with little or no assistance. Though they do not need or want institutionalization, many face this prospect as their caregivers age and

From the Desk of the Chapter President

There are currently over 8,000 people with developmental disabilities on the state waiting list for services and another 1,500 people in institutions who were determined prior to 1998 as being



better served in community placements. A number of states have closed all their institutions. A number of states have significantly increased funding to people with Disabilities, families and the service system. It is time for New Jersey to invest in the benefit of people with disabilities.

Additionally, an increase in Self-Determination and family support funding and the annual operating support of New Jersey Providers of Support is but one of a series of critical issues that must be resolved to maintain and improve the lives of people with disabilities in New Jersey. Other areas that significantly weaken the viability and stability of the community based service structure are:

- ◆ Adjusting annual operational funding support through cost indexing,
- ◆ Long-term capital needs and the intelligent use of them are for Olmstead expansion but also for existing community infrastructure needs to be addressed,
- ◆ Unfunded mandates need to be funded,
- ◆ Identifying and serving the need of an aging DD population with funding

become unable to provide adequate care in the home.

Emmett Dwyer, NJP&A's Director of Litigation, said: "The failure of the state to provide community services for thousands of individuals has had a devastating effect. Thousands of people are stuck at home going nowhere, and many of them have been unnecessarily placed in institutions when their elder parents could no longer care for them. Ten years ago the Legislature demanded that the Commissioner of Human Services come up with a plan to end the waiting list by this year. The plan was drafted, and passed by the legislature, but they never funded it. At that time the waiting list was near 5,000 individuals, as of today it has grown to over 8,000. The irony of the situation is that it costs less to provide services to people in the community that it does to warehouse them in an institution."

Ethan Ellis, Hon. Chairman of the New Jersey Chapter, AAIDD and President of the Next Step: People With Disabilities for Social and Economic Justice stated that, "These individuals fail to get on the waiting list or may be waiting for inadequate or inappropriate services and supports...Many are desperate and placed under extraordinary stress." Moreover, "There are currently several thousand individuals in New Jersey who are on a waiting list for services they are entitled to but are not receiving." As a result of not receiving needed services, individuals "are being discriminated against by having the doors of societal inclusion and participation closed to them. While it appears that AAIDD's constituents live in the community, in reality they live in seclusion because they are being denied opportunities for full participation."

Letter from David A. Rotholz, President, National AAIDD

Dear AAIDD Leaders, Members, and Friends,

Earlier this year the AAIDD Board held a discussion of key issues covering a wide range of topics relevant to AAIDD, its collaborating partners, and our field in general. The agenda focused on our mission, key assumptions, strengths and weaknesses, potential future issues, and how to best position ourselves for a sustained vital national leadership role.

I am pleased to share with you a summary that reflects the consensus of the Board, staff, and invited guests who participated in the retreat. The information in the summary also provides the basis for our new strategic plan currently being developed. What follows is a summary of the key areas of consensus from this meeting. We hope you find it informative and encouraging! This is a time of significant progress and contribution to the field by AAIDD. We believe our association is vibrant, vital, and fortunately in good financial condition.

KEY AREAS OF CONSENSUS (a full report will be forthcoming in the National Strategic Plan, available this spring)

There was unanimous agreement that AAIDD is a professional organization.

As much of the membership is likely to recall, this issue is not one on which there has always been agreement. However, when this issue was discussed in the work session, the Board, guests, and staff all shared the common view that AAIDD is a professional organization that provides a key leadership role for the field. While we continue to welcome and seek active participation from a wide spectrum of those involved and interested in intellectual and developmental disabilities, we do so from the perspective of the leading national professional association in our field.

Our AAIDD Mission Statement continues to serve us well.

AAIDD mission statement: AAIDD promotes progressive policies, sound research, effective practices and universal human rights for people with intellectual and developmental disabilities.

After review, we reaffirmed our position that the current mission statement appropriately conveys who we are why we engage in our activities

Our priorities are Leadership, Knowledge Dissemination, Technology and Partnerships.

These priorities reflect the most important areas of AAIDD focus. Each area encompasses a variety of related important efforts that are key to fulfillment of our mission.

AAIDD issues are global and of interest to disability professionals throughout the world, although we are not an international organization.

In this consensus statement we recognize the worldwide importance and impact of AAIDD's efforts. The contributions of our international colleagues and the numerous languages into which our journals and other

publications are published continue to grow in numbers and diversity.

PRIORITIES

LEADERSHIP DEVELOPMENT and SUPPORT

Recruiting, developing and supporting current and future leaders is critically important to our Association and to the field. We also recognize that recruiting leaders is a "high touch" process.

We recognize that AAIDD is THE organization for professionals in the field of ID/DD. We are the source of knowledge-based leadership in our country and internationally.

Proactive leadership on emerging disability issues is important in our nation and internationally.

KNOWLEDGE DISSEMINATION

There were two key points of consensus in this area:

- ◆ AAIDD is a well-respected source of credible information both in the U.S. and internationally, and
- ◆ AAIDD offers a unique forum where professionals can disagree and debate differing points of view.

TECHNOLOGY

The retreat participants developed four statements to encapsulate our views on technology:

- ◆ Utilization of new technologies is essential in the modern world and must be a part of ongoing association business and professional activities.
- ◆ Technology will increase our ability to form communications networks among members and other interested individuals.
- ◆ Technology-enabled communications groups will help us to identify emerging issues in the field.
- ◆ Technology will increase our international presence by supporting knowledge dissemination.

PARTNERSHIPS

Partnerships are essential if AAIDD is to advance its priorities efficiently and effectively. Our engagement in partnerships with other disability network organizations and reaching out to others in the wider community will facilitate our ability to advance our priorities.

Steps Needed to Advance our Partnership Priority

- a) Fully implement our Cooperative Agreement with AUCD
- b) Continue our governmental affairs partnerships with The ARC, UCP, NACDDS, ANCOR, and AUCD
- c) Work with the Alliance for Full Participation in support of a 2010 Summit
- d) Expand our Cooperative Agreements

ADDITIONAL RELATED ISSUES/ITEMS

Business model:

- a) We should consider rethinking how we do business.

- b) It is important for AAIDD to create new revenue streams.
- c) AAIDD must continue to do work that adds value to the field.

- b) "Market through our Mission". Our approach has been to attract members through the value of our work.
- c) How can we best leverage our relationships with sister organizations for mutual benefit?
- d) It is time to examine our structure and benefits package.
- e) How can we enhance professional benefits to professional members?

What must be done to make it more programmatically and financially viable

Product/Service Ideas:

Is it feasible and advisable to develop a non-technical magazine for ID/DD practitioners?

Advancing Our Agenda:

- a) Should there be more frequent face-to-face meetings of the Board (and guests)?
- b) Should we conduct more frequent "retreat activities" such as environmental scanning?
- c) Should AAIDD establish work groups and committees to address key issues from the retreat and the strategic plan?




