Sidney Katz was born in Newark, NJ on October 13, 1950 and most recently resided in Union, NJ. He graduated from Cranford High School in 1969. Sid was married to Sheryl Seeder Katz in 1978. Sid was actively involved in advocacy for almost half of his entire lifetime. Sid was a 30 year member of Community Access Unlimited (CAU) and one of the 'founding fathers' of the Helping Hands Self-Advocacy Group at CAU; and most recently the New American Movement for People with Disabilities.



Sid was involved in the New Jersey Self-Advocacy Project and New Jersey United Self-Advocates (NJUSA) for over 25 years. He was a former President of both of these groups, and has held

Most recently Sid was the President of Helping Hands, Coordinator for NJUSA - Northern Region & the New Jersey Alternate Representative for the national group, Self-Advocates Becoming Empowered (SABE). Sid was an active member of the American Association on Intellectual and Developmental Disabilities (AAIDD), attending and speaking at many national and regional conferences of AAIDD.
